

Warranty Claim Procedures and Requirements

To obtain warranty service, you may return a defective product to the authorized Street dealer or distributor from which you purchased the Street product. Please confirm the terms of your dealer's or distributor's return policies prior to returning the product. Typically, you must include product identification information, including model number and serial number (if applicable) with a detailed description of the problem you are experiencing. You must also include proof of the date of original retail purchase as evidence that the product is within the applicable warranty period.

You may return the product directly to the Street factory after first obtaining a Return Material Authorization ("RMA") number from Street. An RMA number is obtained by calling Street Customer Service at +1 (818) 757-2300, or email <mailto:support@street-technology.com>

Once you have obtained an RMA number from Street, you must, within thirty (30) days, send the product freight-prepaid and insured to:

Products shipped to the factory must be properly packaged to prevent damage in transit. You must include the Street RMA number prominently displayed on the outside of your package. If you send your product to the factory without the RMA number prominently displayed on the outside of the package, it will be returned to you unopened.
